

Network Origins and Plans for Next Five Years

Phase 1 of Aging Network: 2014-2019

- Create multi-disciplinary, multi-institution network focused on trends and disparities in U.S. adult health
- Launch research trajectories of junior scholars

- Advance scientific understanding of trends & disparities through pilot grants on specific yearly topics
- Four MPIs: Crimmins, Hayward, House, Hummer

Phase 1 Successes

- Membership increased from 30 to >100; disciplinary breadth
- Five annual thematic meetings (post-PAA)
- 20 Pilot Awards
- > 30 grant submissions & at least 14 awards
- >20 peer-reviewed articles

Phase 2 (2019-24): Overall Objective

To strengthen and focus the network of emerging, established, and underrepresented life course and aging researchers to generate new evidence and disseminate data and analytic resources to better understand trends and disparities in U.S. adult health and longevity across the life course and in geographic context.

Context of Project:

- Precipitous fall in U.S. health rankings
- Large & growing disparities
- Life course lens essential; aging as life long process
- Focus on geographic necessary

Aim 1: Direct attention toward targeted scientific questions that will shed light on the multi-layered determinants of the troubling trends and growing disparities in U.S. adult health and longevity.

** How do state and local contexts shape trends and disparities in adult health and longevity by gender, race, and SES across the life course???

- States
- Cities
- Neighborhoods
- Combined levels

Aim 2: Strategically grow the interdisciplinary research network of emerging, established, and underrepresented scientists who will collaborate to investigate the questions in Aim 1.

- Recruit new members, emerging & established
- Aggressively recruit and openly welcome under-represented minority scientists
- Focus the talent on tackling strategic questions

Aim 3: Provide development and training opportunities for Network scientists.

- Pilot grants
- Grant proposal mentoring
- Working groups
- Annual meetings
- Webinars

Aim 4: Develop and disseminate data and analytic resources to foster innovative research on the questions posed in Aim 1 and advance science in this critical area.

- Catalog of contextual databases for aging research
- Strategies for linking databases
- Analytic approaches for examining contextual effects
- Webinars, briefings, and data visualizations






Proposal mentoring program 2020

- Eligibility criteria
 - Network member
 - Should be NIH proposal, prefer NIA-friendly
- Two rounds this year
 - End of May, submission of Aims page+: feedback in June
 - End of July, submission of Aims page+: feedback in August
- Format of feedback meetings June/August
 - PI presents one slide on project
 - Feedback from mentors: two main mentors drawn from PIs to lead feedback, Co-Is and Advisory Board members, others in this group also participate at the meeting
- Later in year, additional grant mentoring via webinar


